Sir,

I am directed to convey the sanction of the government for the official and four cadets listed below to participate in the 20 National Training Camp to be held from 03-10 December 2018 (including travel and transit) in Maldives as per following terms and conditions:

- a. The official and cadets will leave Bangladesh on or the nearest possible date and will return on or the nearest possible date mentioned above.
- b. While participating the program (including travel and transit) they will be treated as on duty.
- c. The official and Cadets will draw their pay and allowances in local currency; no part of it shall be drawn in foreign currency.
- d. Only the expenses of air travel for the invitees to and from Maldives will be borne by the Government of Bangladesh and the expenses of their stay in Maldives will be met by the Maldives Government.
- e. They will not be allowed to stay abroad more than the period approved; and
- f. Team Leader will submit a report on their participation within 15 days after their return.
